will be permitted.
- 5 Starting positions determined by post mark of entry
or time of field registration.
- 6 Field entries will be accepted at 9:30 a.m. in front
of the grandstand Lorain County Fairgrounds on
June 26, 2010.
- 7 Heats will be run at the discretion of the steward.
- 8 Decision of the track steward, timers and judges
will be final. Protests should be directed to the Ohio
Scottish Games, P.O. Box 3, Lorain, OH 44052
together with a \$5.00 processing fee.
